## RELEASE FROM LIABILITY, SAFETY REGULATIONS AND GUEST RESPONSIBILITIES

- Always keep one hand free to hold on to a rail. Only walk along the deck to the front of the boat after consent from the captain.
- We do NOT allow drinking alcohol during your trip or retreat.
- Take precautions with the tropical sun by wearing long-sleaves and seeking shade; do not bring sprays and please use as little ocean life friendly sun screen as possible. Prevent touching our railings, seats and gelcoating of the deck with freshly lotioned skin and hands. Always eek shade when necessary.

## This form is to be signed for agreement before departure from the dock or anchorage.

I UNDERSTAND THAT THERE ARE INHERENT RISKS INVOLVED IN BOATING AND WATER ACTIVITIES including but not limited to perils of the sea, adverse sea and weather conditions, equipment failure, and or acts of other participants and I HEREBY ASSUME SUCH RISKS.

BY SIGNING THIS WAIVER, I TAKE FULL RESPONSIBILITY and waive any claims of personal injury, death or damage or loss to personal property against LIFEASEA - Sail Into Consciousness™ employees, heirs and shareholders.

I agree that any disputes must be settled under the applicable laws.

I UNDERSTAND THAT I HAVE A DUTY TO DIRECTLY INFORM THE CAPTAIN OR CREWMEMBER ABOUT ANY HEALTH OR PHYSICAL CONDITION THAT I MIGHT HAVE such as but not limited to epilepsy, asthma, heart condition, pregnancy, or allergies to food, animals or insects.

I UNDERSTAND THAT I HAVE A DUTY TO EXERCISE REASONABLE CARE FOR MY OWN SAFETY AND MY MINOR CHILDREN, I AGREE TO DO SO.

I ASSERT THAT I AM PHYSICALLY FIT to participate in this boating excursion and its related activities and I agree to hold harmless LIFEASEA - Sail Into Consciousness $^{\text{m}}$  if I am injured as a result of any problem or accident that may arise while participating on the trip.

IN THE EVENT THAT I SHOW SIGNS OF DISTRESS OR CALL FOR AID, I agree to accept assistance from the captain or crew members of the vessel and I agree to hold harmless LIFEASEA - Sail Into Consciousness™, the captain or crew members for their actions in the performance of rescue or first aid;

LIFEASEA© works with qualified and experienced seafarers and makes every and reasonable effort to maintain a safe environment onboard the vessel. Licensed captain and crew members have basic knowledge of performing First Aid Medical Assistance. It is vital you inform your captain of medical conditions and drugs you use.

I fully understand that the involved boat has limited medical facilities and that in the

event of illness or injury, appropriate medical care must be summoned by radio and treatment will be delayed until I can be transported to a proper medical care facility. I agree to these conditions.

I UNDERSTAND AND AGREE THAT: There will be NO tolerance of alcohol abuse on the trip, and that drunken, aggressive or disorderly behavior will NOT be permitted. The captain and/or crew member may refuse me bar service if I become intoxicated and/or present a safety threat to myself or others or the vessel.

I UNDERSTAND AND AGREE THAT: Absolutely NO drugs or illegal substances of any kind, including paraphernalia related to any illegal substance, will be permitted on the boat or the premises at any time.

WEAPONS of ANY KIND ARE PROHIBITED ON BOARD.

I AGREE THAT I WILL ACT RESPONSIBLY and TAKE RESPONSIBILITY FOR MY ACTIONS and respect or obey the orders of the captain and crew, as well as be considerate of my fellow passengers.

I UNDERSTAND THAT further verbal instructions and safety information will be given during the trip and I AGREE to ask the captain or crew if I do not hear or do not understand anything that is said in each and every informative "speech".

I UNDERSTAND THAT IN CASE OF DELIBERATE OR ACCIDENTAL DAMAGE TO THE BOAT OR WATER GEAR I AM RESPONSIBLE FOR REPAIR OR REPLACEMENT. I AGREE THAT THE CAPTAIN CAN CHARGE UP TO 3000 USD ON MY PAYMENT CARD. AN INVOICE FOR THE ACTUAL COSTS FOR REPAIR OR REPLACEMENT WILL BE SENT BY EMAIL FOR ME TO SETTLE POSSIBLY WITH MY LIABILITY (TRAVEL-)INSURANCE.

I HAVE READ THIS AGREEMENT, UNDERSTAND IT, AND AGREE TO BE BOUND BY IT NOW AND FOREVER INTO THE FUTURE.

I have signed this agreement freely and voluntarily under no duress, as an adult above the age of 18 and/ or as the adult caretaker responsible for a minor.
