Field Placement II continues where Field Placement I left off in emphasizing generalist social work practice at the micro, mezzo, and macro levels. In addition to covering social work practice objectives, this course will also address professional and career development issues.

Adjunct Professor. Taught Service Learning in the fall of 2013. This course is designed to expose students to a variety of challenges facing communities in the North Central Texas region and beyond, and to help students develop an understanding of their individual role in addressing those challenges through community service and volunteer activity.

Adjunct Professor. Taught Social Issues in the spring of 2013. This course utilized major theoretical perspectives from Sociology to explore causes and consequences of contemporary social problems in American society such as alienation, family stresses, poverty, unemployment, and technological change.
